- Tami- overall DPOS was very accommodating and open to future discussions
 - DPOS suggested as an alternative for CE instructors to reach out to schools to partner in offering courses
 - Providers may consolidate and band together into a single approved school
 - AMTA & ABMP (National Organizations) are allowed to offer educational classes under their National Association status
- DPOS is willing to look into NCBTMB approved courses to have a decrease in charges, but this is still in the works with DPOS
- ultimately DPOS is bound by statute
- review statute (see Associated documents links below)
- Kris regulatory requirements differ between instructors employed by a school and independent/organizational workshop provider
- liability and ongoing compliance costs shifts to school
- Chris the DPOS stance offers a glimmer of hope in working together, yet won't happen overnight
 - each offering sponsored by a school requires separate approval and ongoing compliance costs
 - Tami mentioned schools are limited to a percent of hours being offered by outside instructors
- Alfred schools are limited to approved brick and mortar locations restricting instructors from offering courses at multiple locations
 - limitations placed on out-of-state instructors to be able to offer courses in Colorado
 - disagrees with DPOS interpretation of statute as it relates to continuing education

- Tami DPOS addressed any education after high school graduation is continuing education
- Kris DPOS holds any private post-secondary (beyond high school) education falls under their purview

- Reports/data on costs involved in determining license renewal were at available at the meeting
- Other DORA question Upcoming Sunset Review
 - Garin believes all costs of Sunset review is already baked into DORA budget and will not impact renewal fees
 - Sunset Review will begin in 2019 and involve stakeholder input
 - Sunset bill will run in 2020
 - begin to review current MTPA and look forward to sunset review considerations (see Associated documents links below)
 - Kathryn reminded the need for clear intent and united efforts regarding Sunset review
- Alfred questioned if deregulation would be a possibility of Sunset review
 - would like greater real-time access to DORA enforcement efforts—too great a delay of reporting on website
