### **Notice of Stakeholder Meeting**

The Division will be holding a stakeholders meeting on February 27, 2019, from 10:00 A.M. to 11:30 A.M. to discuss concerns raised with respect to the Division's oversight of continuing education courses (particularly in the area of massage therapy). During the hearing related to the recently proposed Senate Bill (SB 19- 089), the Division committed to working collaboratively with stakeholders to explore and introduce rule and policy changes that would help in removing the cost barriers to delivery of continuing education courses in Colorado while at the same time preserving the Division's statutory mandate to uphold educational & legal standards and protect students (and consumers).
